The Performance Security will be valid till 23.06.2027 (inclusive of Contract Period, Warranty Period and Defects Liability Period).
- sign the Contract Agreement within 9 (Nine) calendar days of issuance of this NoA but no later than 24.10.2024 (Thursday). However, a Non-Disclosure Agreement (NDA) has to be signed before signing the Contract Agreement.
- complete the related services (e.g. printing and 1st Issuance) and supply all the listed goods within 2 (Two) Months of signing the Contract Agreement but no later than 23.12.2024 (Monday).

You may proceed with the execution of the said Contract accordance with the Contract documents only upon completion of the tasks bearing Serial-(i) to Serial-(iii). You may also please note that, this Notification of Award (NoA) will constitute the formation of this Contract which shall become binding upon you.
